The valid quotation will be opened on date: 12.01.2026 at 11 AM in the office of the undersigned.

Terms & conditions:

1. The bidder should be a registered firm under GST.
2. The quoted rates should be inclusive of all taxes.
3. The delivery of the item should be made to the respective supply order in good condition within 10 days of issue of the supply order.
4. Any conditional quotation will not be allowed.
5. No advance payment will be made against executed of order.
6. The rates should be valid up to one year from the date of finalization of the quotation.
7. If any information / documents furnished by the bidder with the quotation papers are found to be misleading or incorrect at any stage, their quotation will be cancelled.
8. The quotation should be furnished duly super scribed as "QUOTATION FOR REFILLING OF FIRE EXTINGUISHERS".
9. The following documents will be enclosed in the quotation paper, (i) Attested copy of GST registration certificate, (ii) Xerox copy of the PAN card. Original documents may be produced for verification, if asked for.

The undersigned / committee are not bound to accept the lowest rate considering the quality of goods. If required, the firm/supplier has to produce sample of any quoted items for verification.
